## **Data Council Founding**

- 1994 HHS created a department-wide information policy committee that handles cross-cutting data and privacy issues.
- 1995 The Secretary of HHS created the Data Council to continue cross-cutting work related to data privacy and policy.



## Data Council's Chartered Responsibilities

Develop Department-wide data collection strategy, including coordinating and consolidation of surveys

Oversee surveys and general statistical analysis

Work with HHS programs and policy makers, NCVHS (the federal advisory committee), research community, states, private sector, and others, so that data collected by HHS meets the need of all users and be easily accessible.

Serve as HHS's liaison and contact for the NCVHS over time. Aski for issue-specific reports from NCVHS, monitor the work of the NCVHS, make recommendations regarding NCVHS membership, and re-chartering

Respond to data standards and privacy issues presented by the NCVHS and others

Work toward consensus in data standards and privacy

Implement the Vice President's charge to lead an interagency effort in four areas of information system policy: data standards, privacy, telemedicine, and enhanced health information for customers.

  - 7 interviews
- Analysis of all survey data, data walk, and interviews
- Presentation of findings and proposal for new vision
- Next steps






## Which of the following do you currently do? are you most interested in?

## Summary of Data Walk

- 1. Strengthen governance and leadership: Establish clear roles and structures within the council to enhance decision-making processes and accountability, and to provide active guidance in fulfilling the council's mission.
  - 2. Ensure clarity of purpose and relevance: Regularly revisit and align the council's purpose with the current needs and challenges of the organization, ensuring that the council's focus remains relevant.
  - 3. Enhance collaboration and communication: Foster stronger collaboration with other data-related groups within the organization, while improving internal and external communication mechanisms.
  - 4. Balance data sharing and privacy: While promoting data sharing, the council should also prioritize data privacy and work towards finding an optimal balance between the two.
  - 5. Leverage technology and innovation: Utilize AI and other advanced technologies for efficient data analysis and encourage a culture of innovation within the council.
  - 6. Adopt an advisory role and continuously adapt: The council should take on a proactive advisory role in shaping data-related policies and initiatives, while continuously reviewing and adapting its practices in response to changes in the data landscape.

Information should be better disseminated outside of meetings




