## Authority – Evidence Act (+)

- Evidence Act enacted Jan 2019
  - Builds on CIPSEA 2002
  - Requires OMB to issue 3 rules + new policies and guidance
  - Recognizes RSAUs as foundational to generating objective, accurate, reliable,
     credible data for evidence-building

Other related authorities – PRA, IQA, etc.




Foundation built over 100+ years

 Provide for RSAUs to work in an objective, credible, reliable, and accurate manner and enable RSAUs to protect confidentiality


 Additional Congressional requirements meant it was time to review/assess the foundation and strengthen it











#### **Key changes since NPRM:**

- Definition of "Parent Agency"
- Communication, education, engagement, and branding requirements
- RSAU budget presentation and engagement with OMB
- Compliance review
  - IGs to be responsible for reviews with CIGIE to develop guidance for reviews



#### **Example provisions maintained from NPRM:**

- Schedules of release dates
- Consultation with parent agency for relevance
- Maintain publicly available policies and standards on quality
- Autonomy in function and conducting statistical activities
- Protect confidential data and ensure its exclusive statistical use
- Parent agency supports for RSAUs



### What's next?

Rule takes effect 60 days after publication in the Federal Register

- Implementation
  - Joint effort by OMB, ICSP, RSAUs, Parent Agencies, IGs, CIGIE, and the public
  - Will include developing resources and tools to support implementation
  - Will include educating all relevant agencies (RSAUs, Parent Agencies, etc.) on the responsibilities
  - What else should we be thinking about for implementation?
